You are notified that your Bid dated July 25, 2016 for the above Contract has been considered. You are the apparent Successful Bidder and have been awarded a Contract for the **HVAC Replacement-Administration Building Phase 2**.

Replace one (1) of the existing Carrier 208 voltage 10 ton package heat pump with new Carrier equipment. Provide all submittal/performance data and warranty information for all proposed equipment within ten days of completion of project. Equipment must be Carrier brand, model number 50TCQD12A2A5-0A0A0 or 50TCQD12D2A5-0F0A0

- Thermostat for this unit shall be Honeywell VisionPro Series 8000 to match the three units replaced June, 2016.
- Provide and install curb adaptors as needed and secure to existing roof curb. Roof curb dimensions were originally constructed for Carrier Model 50PQ. Supply and return air should be at same end as current.
- Provide and install factory economizers with enthalpy control.
- Provide and install 32KW electric supplemental heater for each unit.
- Provide and install new fusible disconnect switches and associated wiring extensions needed.
- Provide and install new digital programmable thermostats for each system.
- Provide new flexible conduit from roof penetration to new disconnect switch.
- New PVC P-traps are to be included and condensate to terminate to roof.
- Install new smoke detectors in duct as required.

The Contract Price of your Contract is Thirteen thousand, nine hundred fifty-eight dollars and no cents (\$13,958.00).

The proposed Contract Document accompanies this Notice of Award.

You must comply with the following conditions precedent by August 3, 2016 .

1. Deliver to the OWNER 2 fully executed counterparts of the Contract Documents when available. Each of the Contract Documents must bear your original signatures.
2. Deliver with the executed Contract Documents the Insurance Coverage certificates and Contract security (Bonds) as specified in the Instructions to Bidders (Article II), and Specific Terms and Conditions (Article III) and attached here.

Failure to comply with these conditions within the time specified will entitle OWNER to consider your Bid in default, to annul this Notice of Award and to declare your Bid security forfeited.

Within ten (10) business days after you comply with the above conditions, OWNER will return to you one fully executed counterpart of the Contract Documents.
